The holder of the certificate is able:

- to comply with the principles of good manufacturing practice, relevant standards and legislation including hygiene, safety and precautionary measures, and HACCP regulations.

4. Range of occupations accessible to the holder of the certificate ³

Graduates find work as butchers employed in small, medium and large confectioneries and bakeries and in the sale of confectionery and bakery products. After obtaining experience, they are ready to establish a private business. Examples of possible job positions: bookbinder, paper cutter.
